CLASSIFICATION TITLE: Case Manager

GENERAL STATEMENT OF RESPONSIBILITIES:

This is a FLSA non-exempt position. The incumbent is responsible for providing and extending case management, counseling, education and rehabilitation services to adult participants in the Project LINK and Family Treatment Court (FTC) programs. The incumbent must be comfortable serving a diverse group of clients, including but not limited to, those who are chemically dependent, those with mental illness, those who are court-ordered, felons, and clients who are generally difficult to engage in treatment. The incumbent should be comfortable working from a strengths-based, person-centered perspective in order to nurture and develop the client's individual strengths.

In carrying out the responsibilities of this position, the treatment provider reports to and receives general supervision from the program's Director. The incumbent is expected to exercise sound judgment, demonstrate initiative and maintain confidentiality in accordance with established policies and procedures. He/She is expected to perform all duties in accordance with applicable professional ethics state quality assurance standards Department of Behavioral Health and Developmental Services (DBHDS) regulations, as well as established Region Ten policies and procedures.

The HIPPA access level for this position is Level Two

The essential functions of this job are starred below (*) under "Major duties."

MAJOR DUTIES:

- *Provides assessment, case management, care coordination, and referral services for substance abusing or co –occurring persons in the Family Treatment Court and Project LINK programs.
- 2. *Meets with participants of the Family Treatment Court program on a weekly basis for case management services.
- 3. *Provides individual and group therapeutic services to adult clients.
- 4. *Maintains contact with representatives of the various treatment programs involved in the care and rehabilitation of individuals with substance use disorders. Arranges aftercare and follow-up services for individuals in recovery.
- 5. *Conducts client drug screens for Family Treatment Court participants per requirements of FTC program.
- 6. *Coordinates installation and ongoing use of SCRAM alcohol monitoring device for all participants in Phase I of FTC.
- 7. *Provides crisis intervention as needed.
- 8. *Conducts home visits as necessary.
- 9. *Transports clients as necessary.
- 10. *Assists Director to extend and improve program services.
- 11. *Establishes and maintains contacts with FTC and Project LINK partners, including DSS, CASA, and JDR court staff. .
- 12. *Attends Family Partnership Meetings as requested by DSS.
- 13. *Attends all FTC "Roadmap" meetings as requested by FTC Coordinator.
- 14. *Serves as resource consultant.
- 15. *Seeks and receives supervision as required and needed.
- 16. *Maintains current and complete paperwork.
- 17. Compiles weekly reports of FTC participants' progress toward goals and sends to FTC Coordinator.
- 18. *Attends FTC staffing meetings and court proceedings on a weekly basis and provides updates to FTC team.
- 19. *Assist FTC Coordinator in giving presentations within the community regarding FTC.
- 20. *Assist FTC Coordinator in collecting and analyzing data from all service providers for evaluation purposes and reporting to the Supreme Court of Virginia.
- 21. *Meets identified performance standards.
- 22. *Participates in trainings as required by supervisor.
- 23. *Performs other duties as assigned in keeping with general description of this position.
- 24. *Reads all agency communication (i.e., Staff Notes, e-mail, etc.)

QUALIFICATIONS:

To ensure the safe and efficient operation of the program, a valid Virginia Driver's License plus an acceptable driving record as issued by the Department of Motor Vehicles are required. For business use of a personal car, a certificate of valid personal automobile insurance must be provided. Bachelor's degree required. Two years of experience in a program directly concerned with Substance abuse, co-occurring treatment or rehabilitation is preferred. Incumbent must possess Certification in Substance Abuse Counseling (CSAC), or be eligible within 6 months of hire. All candidates must possess and maintain appropriate certification or licensure.
