disorders**



Boxwood Recovery Center

Boxwood provides residential substance use disorder treatment for men and women, 18 and older who live in HPR 1, Loudoun and Prince William counties.

Services include:

- Full range of lab work
- Tuberculosis (TB) testing
- Comprehensive substance use assessment
- Group counseling
- Family program
- Educational videos
- Presentations/lectures
- Individual counseling
- Individualized treatment planning
- Discharge planning and referrals

Length of Stay

Boxwood is designed for 28 days of treatment; however we can accommodate CSB requests for other lengths of stay **based on the individual's** needs.

Admission Criteria

1. Individuals must be medically stable and not experiencing acute medical problems or require continuous medical supervision/care.
2. Individuals must be abstinent from alcohol for 7 days and from all other drugs for 10 days prior to admission. A drug screen is completed upon arrival to Boxwood.
3. Individuals who take medications must bring a 30 day supply in an original, non-expired prescription container.
4. Individuals taking Digoxin, thyroid medication or anticonvulsant must provide documentation of recent therapeutic levels of these medications for our medical staff to review.
5. Individuals are responsible for the costs of any **medications prescribed by Boxwood's** attending physician.
6. Individuals must be TB-free. If a person has tested positive for TB in the past, we require **a physician's certification that the person** is not contagious.
7. Individuals who are pregnant must have documentation indicating the pregnancy is stable. Boxwood will not admit after the 6th month of pregnancy (2nd trimester).
8. Individuals must arrange for transportation to and from Boxwood.

Fees

Fees are determined by the referring CSB. Individuals may be eligible for assistance from SARPOS, probation or parole agencies.

Boxwood does not accept insurance.

Population Served

Individuals requesting treatment must be prescreened by their local Community Services Board (CSB) using the HPR1 Detox and Residential Program Prescreening Form.

We accept dually diagnosed clients with substance use disorders and/or mental health issues.

We are also able to provide services to pregnant females, IV drug users and persons diagnosed with HIV/AIDS. These individuals are given priority status - we will admit them as soon as possible.

As a part of the prescreening, Boxwood needs copies of any discharge summaries, assessments, physicals or other documents related to previous treatment.

Boxwood cannot accept individuals who:

- are not stable on medications
- are actively suicidal or psychotic
- need specialized medical care
- test positive for drugs/alcohol at admission (exceptions may be made for those coming from a medical or detox facility)
